Cardiopulmonary Resuscitation (CPR)

Our CPR Course is designed to teach CPR and relief of foreign

body airway obstruction (FBAO) to all lay rescuers, particularly those who are expected to respond to emergencies in the workplace. Participants include security guards, industrial workers, childcare providers, and other lay responders. Although the course may be used to teach CPR to all lay rescuers, it is specifically designed for lay rescuers who are required to obtain a course completion card, a credential that documents the completion of a CPR course. All rescuers are trained in CPR and relief of FBAO.

First Aid

Our First Aid Course teaches the skills to effectively assess and maintain life from the critical minutes immediately following an emergency until the arrival of emergency personnel. The class teaches lay rescuers to effectively recognize and treat adult and child emergencies.

"Administered within three minutes, the electric shock (defibrillation) restores the normal rhythm to the victim's heart and can increase survival rates from less than 5 percent to nearly 75 percent. Immediate defibrillation can revive more than 90 percent of victims."

Designed for persons who may have to respond in their workplace, home, or community - in short, anyone. Some rescuers are required to take this course as part of their employer's OSHA compliance efforts. The First Aid course is an effective and comprehensive first aid training for workers in any industry, as well as private individuals who want to be prepared to render life-saving aid in an emergency.

Automatic External Defibrillator (AED)

Defibrillation is the treatment of a stopped or faltering heartbeat by an electrical current to the heart. It is the ONLY definitive treatment for Sudden Cardiac Arrest (SCA). Defibrillation administered within four minutes after collapse is most successful; for every minute a victim is unconscious, the prospect of resuscitation decreases by ten percent. After ten minutes the chance of survival is less than one percent.

- · Only defibrillation can reverse SCA

Bloodborne Pathogen (BBP) / Universal Precautions
